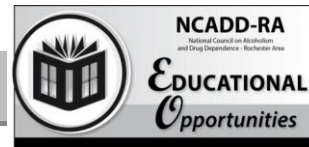

Merge onto BUFFALO RD / NY-33.

End at **1931 Buffalo Rd**, Rochester, NY 14624

From Syracuse and East

From I-90 W / NEW YORK STATE THRUWAY W
Take exit 46 towards 390 North
Merge onto I-490 W toward Buffalo

Take the RT-33 E exit- **EXIT 7A-** toward GATES CENTER.
Merge onto BUFFALO RD / NY-33.

End at **1931 Buffalo Rd**, Rochester, NY 14624

Take I-490 toward Buffalo.
Take the EXIT 7A toward GATES CENTER.
