Take route 490 West. Take the University Avenue exit. Turn left at the first traffic light onto Winton Road. Turn right at the next light onto East Avenue. Take East 1.2 miles. The church will be on your right. Enter the parking lot from either the driveway immediately past Granger Place or the driveway just past the church.

**From the South:**

Take 390 North. Merge onto 590 North, then merge onto 490 West. Exit at Culver Road. Turn right onto Culver. Take Culver for one half mile. Turn left onto East Avenue. Take East Avenue for one-quarter mile. The church will be on your right. Enter the parking lot from either the driveway immediately past Granger Place or the driveway just past the church.

**From the West:**

Take 490 East. Exit at Culver Road. Turn left onto Culver. Take Culver for one half mile. Turn left onto East Avenue. Take East Avenue for one-quarter mile. The church will be on your right. Enter the parking lot from either the driveway immediately past Granger Place or the driveway just past the church.

**From the Northeast:**

Take 590 South to 490 West. Take the first exit, University Avenue. Turn left at the first traffic light onto Winton Road. Turn right at the next traffic light onto East Avenue. Take East Avenue 1.2 miles. The church will be on your right. Enter the parking lot from either the driveway immediately past Granger Place or the driveway just past the church.

**From the Northwest:**
