**A Family Under the Influence: How Substance Use Disorders Impact our Children**

**Content:** Substance Use Disorder (SUD) is a chronic, progressive, potentially fatal, yet treatable illness affecting approximately 1 in 10 Americans. For every person with a SUD, there are others – family, friends, neighbors, and colleagues – whose lives are impacted by the effects of this disease. One out of every four children under the age of eighteen experience SUD in their family which has the capacity to disrupt their health, functioning, and neurodevelopment. This workshop will explore SUD as a family disease and provide a comprehensive understanding of how children are affected. Effective strategies and applications will also be discussed.

**Marijuana Legalization: Implications for Youth, Families, and Communities**

**Content:** This workshop will explore the varieties and potencies of marijuana that is now, with legalization in NYS, more widely accessible. Covered will be signs, symptoms, short/long-term effects, and the range of health risks (physical and mental) supported by examples from current research. We will review associated trends to include the rise of vaping and re-emerging synthetic cannabinoids. Also covered will be current trends (national, state, and local) that inform prevalence. With legalized marijuana, medical and recreational/commercial in NYS, there are a host of enforcement challenges. Included will be a discussion of dispensaries and recent enforcement responses to the many illegal dispensaries that have opened. Discussion will include implications and considerations for our collective work with youth, families, and communities across the continuum.
